

## **Program Summary:**

The Youth Intern Community Program is a one-year intermit learning workshop including training in financial education, technology and leadership for youth ages 15 – 25 offered and supported by the eEnterprises Intl office, located in the MLK Community Center at 3201 E. Republican Street, Room 109A, Seattle, WA 98112. The program teaches Information Technology skills, financial literacy, multimedia skills, leadership and physical training, communications, spirituality awareness and readiness, career development and community service.

It is a great opportunity for youth in Central District Neighborhood to learn new skills, engage with the community, and complete community service hours for college application. The steering committee also known as Central District Youth With Purpose (CDYWP) is the guiding force providing leadership and overseeing the project. The committee will take responsibility for the project feasibility, action plan and achievement outcomes.

The Youth Intern Community Program executes a leadership development program designed by CDYWP to develop future minority leaders in the financial services industry and teach them how to economically empower their communities. There are five focus areas that participants in the program develop through the project based leadership competition: personal leadership skills, financial literacy, business plan preparation, Business Startup/Entrepreneurship, and physical fitness. Participants develop these crucial life skills through classroom and computer laboratory workshops and a series of tele-seminars; developmental heat through an apprentice style group competition and the opportunity to apply the skills learned through the completion of team challenging community action projects.

Participants will participate in quarterly financial literacy tele-seminars led by industry experts. Each participant will be responsible for coordinating a community action project for one of the five focus areas (personal leadership, financial literacy, business plan preparation, Business Startup/Entrepreneurship, physical fitness) within the community they live. The community action projects offer participants the opportunity to develop leadership; teamwork and community skills through teaching the principles of the five focus areas. While completing these empowering projects, participants make a difference in their community and empower themselves to new levels of success.

## Focus Objectives – Discovery, Purpose, Success, Leadership:

The Youth Intern Community Program was established to provide financial assistance to minority and professional students attending a local high school or an accredited college or university and pursuing an Undergraduate or Advanced Degree (Graduate or Ph.D.) in Finance or Business or related financial services disciplines.

- This internship is an eight-month program and must be completed in order to graduate.

## **Program Criteria:**

- Current and previous transcripts minimum GPA: 3.0
- Major course work Business related (i.e., finance, accounting, economics, business, management, business administration, marketing, business law, MIS, technology management, real estate services, insurance, etc.)
- Acceptance letter from accredited college or university and registration invoice or Bursar's receipt
- Reference Letter All applicants are required to provide a signed letter of reference from a teacher or school official, community representative or current/previous employer. This letter should expound on the applicant's demonstrated ability in academics, extracurricular activities, character and leadership (on letterhead, one page maximum). The reference letter can be emailed from the referee directly to UFSC-PS Chapter Mentoring Committee Chair.
- Candidate must submit a 400 500 word essay on "Excellence in Leadership How Do You Personally Exemplify the Quality?"

## <u>Internship Candidates will be selected based on ranking in the following areas:</u>

**Leadership:** Candidates should be able to demonstrate character and leadership skills through their

involvement in community organizations and/or through their place of employment.

Career Goals: Preference will be given to those candidates electing to pursue a career in business,

financial services or a related industry. The candidate's curriculum should reflect the

stated career goal.

**Essay:** Candidates will be judged on written communications skills.
